- 2. <u>Set up information</u>: <u>SET UP WILL BE ON FRIDAY 12:00 pm TO 3:00 PM. THERE WILL BE NO SET-UP VEHICLES PERMITTED ON THE GROUNDS after 3:30 pm Friday. Paid parking begins on Friday evening at 4:00 p.m.</u>
- 3. Tear down information: Exhibits are not be taken down before 9:30 PM on Sunday, and cars, trucks, vans, etc. may not come onto the exhibit area before 9:30 PM. Sunday. All exhibits must be removed from the Fairgrounds no later than 11:00 PM on Sunday. Exhibits are to be open to the public until 9:00 PM all 3 evenings. Security will continue to be provided Friday & Saturday night.
- 4. <u>Display spaces will not be held until your Exhibitor's Contract and payment is received.</u> This includes "under cover" space from the previous year. Space may be limited.
- **5.** <u>Food vendors</u> must have a permit from the Salem Co. Dept. of Health. "Enclosed Mobile Food Trucks" must have a NJ Type One NJ Fire Code Permit. "Home prepared" foods: It is the responsibility of vendors who sell home prepared foods (foods prepared in a kitchen that has not been inspected by the Local Health Dept.) to contact the Salem County Dept. of Health (856-935-7510 x 8448) to secure an "Unregulated Food Notice".
- 6. Adequate lighting will be supplied by the Fair Assn. (You will need a ladder and long cord!)
- 7. Security protection around the clock is provided and all <u>reasonable</u> precautions are taken to protect the exhibitor's property. <u>Special items of value should be removed overnight</u>. Booths not manned are the responsibility of the vendor. The Fair Assn. is not responsible for any items left after Sunday evening at 11:00 p.m.
- 8. NO Gambling and selling of chances will be permitted during this event.
- 9. All buildings and the attached shed row booths are smoke free.
- 10. Tents: It is the exhibitor's responsibility to see that their tent has a fireproof rating indicated.
- 11. Live animals can not be sold. No crafts/etc. that resemble "weapons" can be sold.
- 12. Motorized vehicles: only vehicles operated by Fair personnel can be used on the grounds.
